








Rotterdam as gateway to Europe








CAREER AND ALUMNI

✓ The industries that attract most RSM graduates are consultancy and business research (23%) and financial services and insurance (22%).

√ 96% of RSM alumni were employed, doing an internship, had started their own business or worked freelance within a year of graduation. Average search time is 3 months.

Industries employing RSM graduates



✓ Non-EEA students can apply for a Search Year permit within 3 years after graduation for every Dutch higher education degree. 1 for a finished BSc and another one for a finished MSc. The search year permit can be used to search for work, perform a part-time/full-time job (paid or unpaid) or do voluntary work.


